## Agenda Item 8 – Public Comment

Staff proceeded to address public comments, starting with in-person comments, then those with their hands raised on Zoom, and then comment sent in via email. The following member of the public made comments:

The only public comment received prior to the meeting in California Broadband Council inbox came from Philip Neufeld (Copied Below), which was also verbalized by Mr. Philip Neufeld during Public Comment.

"I am Philip Neufeld. Executive Officer of IT at Fresno Unified School District and Co-Founder of the Fresno Coalition for Digital Inclusion.

We learned during the pandemic the substantial gaps in internet infrastructure, how internet providers choose not to adequately serve areas of higher poverty, and the large number of unserved residents in urban and rural areas of poverty who do not yet show up on the state's broadband maps.

For example, the CPUC maps suggest Fresno County has around 3% of its residents who are unserved. Yet, the 2020 ACS showed 17% unserved and the Microsoft Digital Equity dashboard showed 50% unserved in Fresno County. Our 11,000,000+ myQoI speedtests from student laptops suggest 27% of the City of Fresno is unserved.

These areas of digital disinvestment most often affect vulnerable populations and traditionally marginalized communities barring these residents from participation in services like telehealth, online education, job searches, and so much more.

We've learned that many unserved residents live in multi-dwelling units. Yet these residents, about 30% of our population, are not counted as unserved.

We urge the CPUC to prioritize infrastructure investments in multi-dwelling units within the broadband plan, right after "unserved populations". We urge improvements to the broadband map to more equitably guide infrastructure investments and have offered the CPUC ways to improve those maps with crowd-sourced speed tests like myQoI (developed by Fresno Unified)."
